A Clean Business is Good Business

Storm water and health regulations require a high standard of maintenance in dumpster areas to decrease litter, spills, and container overflows. Containers for cardboard, mixed recycling, and food waste require proper upkeep to avoid added fees, increase accessibility for servicing, and reduce contamination. Please keep lids for tallow tanks and barrels securely on at all times to prevent spills. Cleaning a spill right away is always the right thing to do. A clean and tidy dumpster area can also help prevent illegal dumping from becoming a problem on your business property.

Watsonville is committed to a clean and safe community. As part of the City's Beautification Initiative, businesses and neighborhoods will be held accountable for keeping properties clean.

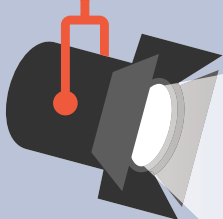
How Can Businesses Achieve This?

- Keep container lids closed and locked at all times.
- Ensure containers have clear labels to distinguish the differences between them.
- Nothing should be left or stored outside of containers and enclosures.
- Never pour liquids in the dumpsters.
- Train staff and require daily monitoring.
- **Report illegal activity or leaking containers.**

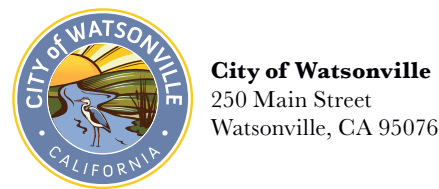
Electronic waste (e-waste) is the fastest growing segment of waste. Common items like **batteries, phones, fluorescent light bulbs, calculators** and **appliances** contain hazardous material that must be sent to a certified facility for disposal. Please help by clearly labeling a container for all e-waste and delivering to the City's Waste & Recycling Center at 320 Harvest Drive. Quantities of up to five fluorescent light bulbs are accepted.

Save Water, Save Money!

The City offers **FREE water conservation consultations** to help businesses save! Staff will evaluate your landscape and indoor water use and provide recommendations tailored to your business. You may also be eligible for a rebate of up to \$1,000/yr to replace lawns with drought-tolerant, permeable landscaping. A pre-inspection site visit is required. To schedule your appointment call **(831) 325-3376**.
