Responses to Bidders' Questions

Item 2-2 **The following contractor questions and City responses are provided.**

Question #1 – Our DBE Subcontractor Attestation form is due 5 calendar days after the bid submittal. The 5th calendar day is Sunday, June 30th. Can we submit our paperwork on Monday, July 1st or do we need to have it to you by Friday, June 28th? Would you like us to email you all the DBE paperwork or send the originals to 250 Main Street?

Answer #1 – The DBE Subcontractor Attestation form and subcontractor CARB issued Certificates of Reported Compliance need to be submitted within 5 calendar days. Friday June 28th would be acceptable, but Monday July 1 is not acceptable as it is outside the 5 calendar day requirement. Please email a copy to sam.rosas@watsonville.gov and deliver hard copies to 250 Main Street.

Question #2 – PLA – Do we need to sign and submit the Agreement to be Bound form and submit it with our bid?

Answer #2 – The Master Project Labor Agreement (PLA) Agreement to be Bound included in Appendix C of the specifications does not need to be included in your bid submission. This PLA will need to be signed along with the contract after award of the project.

Question #3 - CARB IUOR Fleet Certification – The bid packet has the In Use Off Road Diesel Fueled Fleets Certification form that we will complete and submit our CARB certificate with this form. Do we need to also submit our subcontractor's CARB certificates with our bid?

Answer #3 – The In-Use Off-Road Diesel Fueled Fleets Certification form only needs to be submitted by the prime contractor. However, this submission certifies that your subcontractors will also comply, so the prime contractor is responsible to verify compliance of the subcontractors. The CARB issued Certificate of Reported Compliance for the prime contractor must accompany the bid and the CARB issued Certificates of Reported Compliance for subcontractors must accompany the bid or be submitted no later than 5 calendar days after date bids are opened. (see In-Use Off Road Diesel-Fueled Fleets Certification revised per Item 1 of this Addendum #2)

Question #4 - DBE Documentation – Instructions to Bidders #11, Basis of Award, states:

As a condition of responsiveness, the Bidder or Offeror must submit the following information with its proposal utilizing the “City of Watsonville Assurance of Disadvantaged Business Enterprise Participation” form provided in the Proposal Form, along with all required supporting documentation required by that document.

- 1) The names and addresses of Disadvantaged Business Enterprise (DBE) firms that will participate in the contract;
- 2) A description of the work that each DBE firm will perform;
- 3) The dollar amount of the participation of each DBE firm listed under (1);
- 4) Written statement from Bidder or Offeror that attests their commitment to use the DBE firm(s) listed under (1) to meet the Owner's project goal
- 5) Written confirmation from each listed DBE firm that it is participating in the contract in the kind and amount of work provided in the prime contractor's commitment; and
- 6) If Bidder or Offeror cannot meet the advertised project DBE goal, evidence of good faith efforts undertaken by the Bidder or Offeror as described in appendix A to 49 CFR part 26. The documentation of good faith efforts must include copies of each DBE and non-DBE subcontractor quote submitted to the bidder when a non-DBE subcontractor was selected over a DBE for work on the contract.

Would you like us to submit all of this with our bid? Or can we just submit the DBE Utilization Form & DBE Participation with our bid? We will be submitting the DBE Subcontractor Attestation form 5 calendar days after our bid. Can we submit #4-6 above with our 5-calendar day submittal instead of at bid time?

Answer #4 – Submission of the DBE Utilization Form and DBE Participation List are to be submitted with the bid. The DBE Subcontractor Attestation form can be submitted within 5 calendar days of the bid (see Question #1 of this addendum). This will satisfy all conditions listed in items 1-5 of the Instructions to Bidders #11. If applicable, Item 6 of the Instructions to Bidders #11 DBE Good Faith Effort, shall be submitted with the DBE Utilization Form at the time of bidding.
